2. HAZARDS IDENTIFICATION

Main hazards: Harmful if swallowed. Irritating to eyes.

3. COMPOSITION / INFORMATION ON INGREDIENTS

Hazardous ingredients: FERRIC SULPHATE 100.000%

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.

Eye contact: There may be irritation and redness.

Ingestion: There may be soreness and redness of the mouth and throat. There may be difficulty swallowing. Nausea and stomach pain may occur. There may be vomiting.
